9. Changes to the constitution. Replace sections 10, 11 and 12 with the following:-

10. The Treasurer

The Treasurer shall be required to attend all Committee Meetings, Annual General and Extra-ordinary General Meetings, keep the books of the Club, and produce a report of the Club's cash position and income and expenditure for the year end to 30th June, or any other such date as may be set at an A.G.M. of the Club. They will manage the Club's online bank accounts, but will only have the authority of the Committee to make bank transfers jointly with another authoriser as named on the Mandate. All expenditure over £300 must be authorised by the Committee. The Treasurer will provide details at the Committee Meetings of all expenditure incurred between Committee Meetings for information purposes.

11. Annual report of accounts

The annual report of the Club's cash position and income and expenditure prepared by the Treasurer are to be presented at the A.G.M.

12. Bank Mandate

Club members authorised to access the Club's online bank accounts, jointly-approve cash transfers or sign cheques shall be registered with the Club's Bankers on an approved form of mandate. They will normally consist of: The Treasurer, The Barn Booking Secretary, The New Members' Secretary, and one/two other Committee Members. Any two named on the mandate may authorise an online payment or sign a cheque.

10. Election of new committee members

All committee positions are open for re-election on a yearly basis, so you can stand for or contest any position. The committee positions are:
