# Identification & listing of members present

## **Election of a chairperson**

## **President's Report**

**Paul Sagar** presented his report, summarising that despite the difficulty of working around Covid restrictions the club remains healthy in terms of finance and membership and has managed to conduct a reasonable number of meets and social events thanks to the input of the membership.

There were no questions raised.

A vote of thanks was offered to John Wallbank for his work as Hut Warden.

#### Treasurer's Report

**Paul Sagar** (as Catrin Nichols could not attend) presented this report, as shown in attached **Appendix A1 & Appendix A2**. There were no questions.

#### Membership Secretary's Report

**Paul Sagar and David Barlow** (as Mark Wilkinson could not attend) presented this report as shown in attached **Appendix B**.

## Agenda item – BMC inflation-linked Membership Fee adjustment

The recent notification of the intent of the BMC to annually increase their Membership Fees in line with inflation was raised and discussed.

#It was proposed that the fees for booking the Barn could be increased to cover this rather than the club raising the membership fees, and that some comparative research could be done in this area.

The Motion was proposed and carried that the club should not carry the cost of the increase but that a solution should be investigated by the committee and communicated at the next AGM.

## **Any Other Business**

There were three proposals raised by members.

- 1. \*Proposal One by Member Richard Haszko that gas cut-off valves be installed in the buildings to avoid repetition or risk of the gas being left on.

  The committee agreed to investigate this matter at the next committee meeting.
- **2. Proposal Two** by Member Marion Wintringham that the club release annually and/or store accessible to club members only a list of the address and contact details of all members to facilitate contact between members not in London or active on the Chat Forums. The committee agreed to investigate this matter at the next committee meeting with particular reference to GDPR regulations.
